

THE SEVEN KINGDOMS EXPERIENCE
OFFICIAL DETAILS (these “Official Event Details”)

DESCRIPTION

THE SEVEN KINGDOMS EXPERIENCE promotion (the “**Event**”) is an event experience produced by Scientific Games, LLC (“**SG**”) in connection with participating state lotteries (the “**Lotteries**” or “**Lottery**”). The Event will take place in Calistoga, California, in or about Fall of 2025. The specific date and location of the Event are subject to change at the sole discretion of SG and should the date and location change, SG shall make every effort to post the update to the Lottery’s website no later than ninety (90) days prior to the Event.

Lottery trip prize winners (each a “**Contestant**” or plural, “**Contestants**”) are randomly selected by participating Lotteries per individual state Lottery rules. The total number of Event Contestants depends upon Lottery participation levels. Each Contestant will receive a Lottery-sponsored trip to Napa County, California and San Francisco, California to participate in a non-broadcast, lottery-winners-only **THE SEVEN KINGDOMS EXPERIENCE** for the chance to win a shared cash prize from twenty-five thousand dollars (\$25,000) up to seven million dollars (\$7,000,000) (a “**Prize**” or plural, “**Prizes**”) as further described below.

CONTESTANT ELIGIBILITY

Each Contestant or his or her Proxy must be at least eighteen (18) years of age or older and meet all eligibility requirements as determined by individual Lottery regulations to be eligible to participate in the Event. If a Contestant is not eighteen (18) years of age, the Contestant shall assign a Proxy to play on his or her behalf. If the Contestant does not timely assign an eligible Proxy to play on his or her behalf, SG shall assign an eligible Proxy. SG may also appoint a Proxy should the Contestant arrive at the Event and in SG’s judgement is intoxicated or otherwise is incapable of participating in the Event.

Proxy - A Proxy will be a non-Contestant who could be designated by a Contestant or assigned by SG to participate in the activities described herein. Proxies are not entitled to keep any winning(s) won on behalf of a Contestant. Notwithstanding any portion of these Official Event Details to the contrary, a Proxy **assigned by SG** to participate in the Event on behalf of a Contestant shall not be vested with the power, authority or discretion to (i) make any decision pertaining to these Official Event Details for or on behalf of the Contestant represented by such assigned Proxy; or (ii) risk or forfeit, during the conduct of the Event, any winnings of ten thousand dollars (\$10,000) or greater won by the assigned Proxy on behalf of the Contestant represented by such assigned Proxy. Conversely, however, a Proxy **designated by a Contestant to participate in the** Event on behalf of such Contestant shall be vested with the power, authority and discretion to (i) make decisions pertaining to these Official Event Details for or on behalf of the Contestant represented by such designated Proxy; and (ii) risk or forfeit, during the conduct of the Event, any winnings won by the designated Proxy on behalf of the Contestant represented by such designated Proxy. **Further, no Proxy shall be assigned or designated to participate in the Event on behalf of any Contestant who is ineligible to participate in the Event.**

SG reserves the right to verify eligibility of each Contestant to participate in the Event and, by signing these Official Event Details below, the Contestant consents to a background check.

Contestant and Contestant's travel companion are responsible for ensuring their respective compliance with the REAL ID Act, to the extent such Act is applicable to the Contestant's or the Contestant's travel companion's air travel. The REAL ID Act modifies U.S. federal law pertaining to security, authentication, and issuance procedures standards for state driver licenses and identity documents, as well as various immigration issues pertaining to terrorism.

In addition, the following individuals shall not be eligible to participate:

- (a) an employee, officer or director of any participating state lottery, SG, SCA Promotions, Inc., Warner Brothers Consumer Products Inc., or its affiliates, or any contractor or consultant under agreement with any participating state lottery or SG;
- (b) a contractor or consultant, under agreement with the any participating state lottery or SG or its affiliates, to review or audit the Event, these Official Event Details and **THE SEVEN KINGDOMS EXPERIENCE** Event and Security Procedures (the "**Event and Security Procedures**");
- (c) an employee of an independent accounting firm, under contract with any participating state lottery or SG or its affiliates, to observe drawings or site operations and actually assigned to a participating state lottery or SG or its affiliates account and all partners, shareholders, or owners in the local office of the firm;
- (d) an immediate family member (parent, stepparent, child, stepchild, spouse, or sibling) of an individual described in subsections (a), (b), and (c) and residing in the same household; or
- (e) those persons designated by any applicable law, rule, or regulation in the jurisdiction of a participating state lottery as ineligible to play its games.

SG reserves the right in its sole and absolute discretion to disqualify any Contestant that it suspects or finds does not meet Eligibility requirements, fails to comply with these Official Event Details, has provided inaccurate information on any documents submitted in connection with the Event, is acting in a disruptive manner or with the intent to annoy, abuse, threaten or harass any other person, or displays behavior that has the potential to damage the reputation of SG, the Event, or any other person or entity associated with the Event. In the event of disqualification, any and all privileges as a Contestant will be immediately terminated, including the right to receive any Prizes that may already have been won.

To participate in the Event, eligible Lottery ticket holders must:

- (a) Be randomly selected by the participating Lottery in one (1) or more promotional, second-chance drawings from among all eligible entries received during the official entry periods;
- (b) Meet all participating Lottery selection and Prize validation requirements; and
- (c) Upon validation, enter the Event through the participating Lottery's promotional, second-chance website/app or an alternative entry method as applicable following all entry rules established by the participating Lottery. *

**(See participating Lottery website for official entry and drawing rules.)*

EVENT OVERVIEW

Prior to arrival at the Event, each Contestant will be randomly assigned, using a Random Number Generator (“**RNG**”), to one (1) of seven (7) **houses** (each a “**House**” or plural, “**Houses**”), as a member (hereinafter a Contestant may be interchangeably referred to as “**House Member**” or plural “**House Members**”) and assigned a House Member number (a “**House Member #**” or plural “**House Member #s**”). The seven (7) Houses will consist of (i) House Baratheon; (ii) House Greyjoy; (iii) House Lannister; (iv) House Mormont; (v) House Stark; (vi) House Targaryen; and (vii) House Tyrell. The number of House Members in each House will be determined based on Lottery participation, but in the case of a Prize split (a “**Prize Split**”), or total shared Prize value won, will be divided evenly by no more than sixteen (16) per House, even if there ends up being more than sixteen (16) House Members in a House. A Prize Split will occur in Rounds #1 and #3.

The Event will consist of a Pre-Event Selection, immediately followed by three (3) rounds (each a “**Round**” or plural, “**Rounds**”) as detailed below. Each Round will be played separately as follows:

PRE-EVENT HOUSE RULER SELECTION:

Prior to the start of Round #1, one (1) House Member from each of the seven (7) Houses will be randomly selected, using a ball machine (the “**Ball Machine**”), as the House ruler (each a “**House Ruler**” or plural, “**House Rulers**”). Each of the selected House Rulers will be announced before the start of Round #1.

Each House will be instructed to stand one at a time and the Ball Machine, containing numbered lottery balls (the “**Lottery Balls**” or singular “**Lottery Ball**”) corresponding to the number of House Members in each House, will select the House Ruler for each House. For each House, the Event host (the “**Event Host**”) will release the Lottery Balls into the blowing chamber and start the Ball Machine. The Lottery Balls will mix for no less that twenty (20) seconds. The Event Host will press the draw button, causing the Ball Machine to select one (1) Lottery Ball. The House Member with the House Member number corresponding to the selected numbered Lottery Ball will be deemed the House Ruler for that House.

If for any reason the Ball Machine selects more than one (1) Lottery Ball, only the first Lottery Ball selected will determine the House Ruler. In the event of a Ball Machine malfunction, the Event Officials may elect to utilize an alternate approved method for randomly selecting the House Ruler.

ROUND #1 JOUSTING TOURNAMENT:

Each House will be randomly assigned a jouster (each a “**Jouster**” or plural, “**Jousters**”) for the chance to win a Prize to be split evenly among House Members of each House. The Jousting Tournament will include three (3) matches (each a “**Match**” or plural, “**Matches**”) as follows:

(a) Match #1- Quarterfinal:

Before Match #1 begins, one (1) of the seven (7) Houses will be randomly assigned a tournament bye (the “**House Bye**”) and will not be paired with another House for Event play, automatically advancing to Match #2. The remaining six (6) Houses will

participate in Match #1. Three (3) Houses will be eliminated, with each awarded a twenty-five thousand dollars (\$25,000) Prize Split and their House Event play activity ends. The three (3) remaining Houses, along with the House Bye, will advance to Match #2.

(b) Match #2 - Semifinal:

Four (4) Houses will participate in Match #2. Two (2) Houses will be eliminated, with each awarded a one hundred thousand dollars (\$100,000) Prize Split and their House Event play activity ends. The two (2) remaining Houses advance to Match #3.

(c) Match #3 - Final:

The two (2) remaining Houses will participate in Match #3. One (1) House will be eliminated and awarded a two hundred fifty thousand dollars (\$250,000) Prize Split and their House Event play activity ends. One (1) House will be awarded a one million dollars (\$1,000,000) Prize Split and will become the House Finalist in Round #3.

***The Match pairings and Jousting Tournament Matches will be randomly selected outcomes, using an RNG, prior to the Event.**

ROUND #2 DRAGON EGGS BONUS:

Each of the seven (7) House Rulers will have the opportunity to win an individual Prize Bonus from seven thousand dollars (\$7,000) up to seventy-seven thousand dollars (\$77,000) that will not be shared with their House. At the start of Round #2, the Event Host will call upon each House Ruler, in their randomly selected order, to select one of the fifteen (15) numbered dragon eggs (each a “**Dragon Egg**” or plural, “**Dragon Eggs**”). At time of selection, the Event Host will ask each House Ruler to select a numbered Dragon Egg, announce his or her numbered Dragon Egg selection before retrieving their Dragon Egg. Once all House Rulers have made their selection, they will be instructed to simultaneously open their Dragon Eggs to reveal a message inside. Each Dragon Egg will contain a randomly placed sealed security envelope of identical outward appearance and weight (the “**Envelope**” or plural, “**Envelopes**”).

Each Envelope will contain only one (1) of the following messages:

- (a) One (1) Envelope will contain an insert with a “\$77,000” message;
- (b) Two (2) Envelopes will contain an insert with a “\$27,000” message;
- (c) Three (3) Envelopes will contain an insert with a “\$17,000” message; and
- (d) Nine (9) Envelopes will contain an insert with a “\$7,000” message.

Each House Ruler will win the individual Prize Bonus revealed in their Dragon Egg Envelope and their Event play activity ends, with the exception of the House Finalist Ruler from Round #1 who will advance to Round #3.

ROUND #3 THE SPOILS OF WAR:

The House Finalist Ruler from Round #1 will spin a wheel (the “**Wheel**”) for the chance to win up to an additional six million dollars (\$6,000,000) Prize Split.

The House Finalist Ruler will receive three (3) separate spins of the Wheel (each a “**Wheel**”)

Spin” or plural, **“Wheel Spins”**) displaying twenty-four (24) equally sized segments distributed around the perimeter of the Wheel. The segments will display the following messages:

- (a) One (1) segment displays **“\$2,000,000”**;
- (b) One (1) segment displays **“\$1,000,000”**;
- (c) One (1) segment displays **“\$500,000”**;
- (d) One (1) segment displays **“\$250,000”**;
- (e) Twenty (20) segments display **“\$25,000”**; and
- (f) One (1) of the aforementioned **“\$25,000”** segments also displays a gold star symbol and the word **“START”** which indicates the required starting position of the Wheel prior to each Wheel Spin (the **“START Segment”**). This START Segment will be positioned directly opposite the **“\$2,000,000”** segment.

The House Finalist Ruler spins the Wheel three (3) separate times. At the conclusion of Round #3, the House Prize Split will be the cumulative Prize amount indicated on the outcome segments on each of the three (3) separate Wheel Spins and will be added to the one million dollars (\$1,000,000) Prize Split from Round #1.

For a Wheel Spin to be considered an **“Eligible Wheel Spin”** the following conditions must be met:

- (a) The Wheel must start with the click tab at the top of the Wheel resting on the START Segment;
- (b) Each Wheel Spin must rotate in a clockwise direction;
- (c) Each Wheel Spin must complete three (3) full rotations before coming to rest on an outcome segment; and
- (d) Once the Wheel is released by the House Finalist Ruler, the Wheel must come to rest without interference from any person or object, other than interference from the components of the Wheel itself.

Should the Wheel Spin not meet the aforementioned Eligible Wheel Spin criteria, and a Wheel Spin is deemed an **“Ineligible Wheel Spin”**:

- (a) The House Finalist Ruler may spin the Wheel exactly one (1) more time. If on the second attempt, the Wheel is deemed an Ineligible Wheel Spin, the House Members will win the minimum Prize of twenty-five thousand dollars (\$25,000) for that Wheel Spin attempt. *The House Finalist Ruler will be given the opportunity to assign a House Member to complete the second Wheel Spin attempt on their behalf and will complete all remaining Wheel Spins (the **“Wheel Spin Proxy”**). The Wheel Spin Proxy is excluded from the Contestant Eligibility Proxy language above.*
- (b) Wheel Spins touched or interfered with by the House Finalist Ruler, Wheel Spin Proxy, or any House Member: the House Finalist Ruler will not receive another Wheel Spin attempt, and the House Members will win the minimum Prize of twenty-five thousand dollars (\$25,000) for that Wheel Spin attempt.

If the Wheel comes to rest on the “\$2,000,000” segment two (2) times, a security check must be performed on the Wheel before any further attempts occur.

In the event the Wheel should experience a mechanical failure, malfunction, or other such occurrence that renders the Wheel inoperable for any reason, any remaining Wheel Spins will be transitioned to and conducted using security envelopes of similar outward appearance, with the same dollar amounts listed above. The odds of obtaining the respective Wheel Spin outcomes using the security envelopes shall be the same as those odds resulting from the use of a properly functioning Wheel.

PRIZE ALLOCATION

Prize allocation for each Contestant will be awarded as detailed above. All Prizes awarded during the live Event are the sole responsibility of SG and/or third-party underwriter. Participating Lotteries shall have no liability for any Prizes awarded during the live Event.

Prior to dismissal, Contestants are reminded that their Prize winnings will be sent to them as per the terms and conditions of the Event, subject to the condition that the Contestant meets all eligibility requirements and remains in compliance with these Official Event Details which each Contestant is required to duly execute in order to participate in the Event.

Prizes are not considered won by a Contestant, and are not payable unless and until the following conditions are met:

- (a) SG and/or the third-party underwriter of such Prize(s) certifies that the Event has been conducted appropriately and in accordance, in all material respects with these Official Event Details and the "Event and Security Procedures";*
- (b) SG and/or the third-party underwriter of such Prize(s) certifies that a Contestant has validly won the Prize pursuant to these Official Event Details and the Event and Security Procedures and is entitled to receive the Prize;*
- (c) SG and/or the third-party underwriter has accepted the obligation to pay the Prize to the Contestant; and*
- (d) The Contestant meets all participating Lottery selection and Prize validation requirements.*

Prizes are not for resale and are not transferable.

All taxes on any Prizes are the responsibility of the Contestant. The total amount of the Prizes awarded at the live Event by the Contestants will be provided to each Contestant as outlined in these Official Event Details. SG or its designated agent shall withhold from all Prizes the minimum required federal and state withholding taxes and shall deposit said withholdings on behalf of the Contestants to the appropriate agencies. Each Contestant must supply a complete and valid IRS Form W-9 to SG prior to and as a condition of receiving a Prize. The Contestants shall receive an IRS Form W-2G from SG and a copy shall be provided to the Lottery, upon request.

Contestants release SG and its parents, subsidiaries, affiliates or divisions, and all persons and entities connected with the Event, of any and all liability in connection with any such taxes.

FAILURE TO COMPLY WITH ANY OF THESE OFFICIAL EVENT DETAILS, EVENT & SECURITY PROCEDURES, INDIVIDUAL EVENT GUIDELINES, ANY OTHER GUIDELINES, OR CODES OF CONDUCT SET FORTH BY SG, MAY RESULT IN A CONTESTANT'S DISQUALIFICATION AT SG'S SOLE AND ABSOLUTE DISCRETION AND/OR THE REVOCATION OF ANY PRIZE WON.

PUBLICITY

Except where prohibited, participation in the Event constitutes each Contestant's consent to SG's and its agents' use of Contestant's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment, consideration, or notification.

REPRESENTATIONS, WARRANTIES, AND INDEMNITY

Each Contestant represents and warrants that he or she has read, understands, and will follow these Official Event Details. Contestant agrees (as permitted by applicable law) to indemnify and hold SG, from and against any and all claims, liabilities, costs and expenses, (including reasonable attorney's fees) arising from a breach by the Contestant of any representation, warranty or covenant made by such Contestant in connection with his or her acceptance of and participation with these Official Event Details and Event activities.

WAIVER OF LIABILITY AND RELEASE

By participating in the Event, Contestant discharges and fully releases and agrees to hold harmless, SG and any other entities associated with the Event, and all of their respective officers, directors, employees, agents and representatives, (the "**Released Parties**") from any and all liability, injury, damage or loss that may occur, directly or indirectly, in whole or in part, from or in connection with the Contestant's participation in the Event or from the receipt or use of any Prize or from any activity related to the receipt or use of any Prize. By receipt of a Prize, each Contestant agrees to release and hold harmless the Released Parties from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Event or receipt or use or misuse of any Prize.

LIMITATIONS OF LIABILITY

SG is not responsible for computer hardware or software malfunctions, failures or difficulties, or other errors or problems of any kind whether human, mechanical, electronic, network, computer, typographical, printing or otherwise relating to or in connection with the Event, including, without limitation, errors or difficulties which may occur in connection with the administration of the Event, the announcement of Prizes, functionality of the application or in any Event related materials. SG is also not responsible for any incorrect or inaccurate information, whether caused by a Contestant, tampering, hacking, or by any applications, equipment or programming associated with or utilized in the Event. SG is not responsible for any injury or damage to persons or property, which may be caused, directly or indirectly, in whole or in part, from Contestant's participation in the Event or receipt or use or misuse of any Prize.

Neither the Lottery, SG, nor other companies, including, but not limited to Warner Brothers Consumer Products Inc. or its affiliates directly associated with the Event shall be responsible to Event entrants or to any other person for data entry errors resulting from or caused by the entering, keying or mis-keying of the required ticket information by Event entrants.

ANY ATTEMPT BY A CONTESTANT TO DELIBERATELY DAMAGE OR UNDERMINE THE EVENT OR LEGITIMATE OPERATION OF THE EVENT IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE; SG WILL DISQUALIFY ANY SUCH CONTESTANT AND RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH CONTESTANT TO THE FULLEST EXTENT PERMITTED BY LAW.

ADDITIONAL RULES AND PROCEDURES

In the event SG needs to stop the Event for any reason (including but not limited to human, mechanical, equipment failure, rule violation, or safety issues), the Contestants and/or the Event elements (e.g., but not limited to the *Ball Machine, Lottery Balls, Dragon Eggs, Envelopes, Wheel, and Jousting Tournament*) may be reset to a particular position, or the entire Event may be restarted from the beginning, at SG's sole and absolute discretion. SG reserves the right to modify these guidelines at any time, with or without notice, in its sole discretion.

An independent auditor(s) will audit all Event Rounds.

ADDITIONAL ADDENDA AND/OR GUIDELINES

Any additional addenda and/or guidelines required by SG for the Event will be provided to and/or briefed to the Contestants prior to the Event and such guidelines and/or addenda, whether delivered in writing, or verbally during the Event, will be deemed added to this document and fully incorporated herein.

SOCIAL MEDIA USAGE

At no time during the Event shall the Contestants or their Guest be allowed to take photographs or videos. All Event play is proprietary and not for public viewing. No photos or video of the Event play are permitted to be posted to any Social Media outlet. Use of cell phones, cameras or video cameras is strictly prohibited.

MISCELLANEOUS GUIDELINES

Any and all advice that may be given by the Event Host (who will be selected by SG in its sole discretion), the audience, other Contestants, SG and/or other production personnel will be taken at the Contestant's sole risk. Contestants (or their assigned Proxies) are solely responsible for any decisions they make or actions they take within the confines of the Event.

Contestants must make themselves available for the entire Event (and any additional time

reasonably requested by SG) for the purpose of conducting the Event.

At no time may a Contestant attempt to impede, hinder or interfere with a fellow Contestant at any time during the Event. Doing so may result in disqualification by SG, in its sole and absolute discretion.

No Contestant may collude with any other Contestant, Event Host, audience member, production personnel or otherwise try to “*fix*” (i.e., predetermine) the result of any portion of the Event.

Unless approved in writing by SG, Contestants are not permitted to share any Prizes with any other Contestants. Contestants will be monitored throughout the production of the Event.

If applicable, Contestants and guests shall follow all health and safety protocols, including always wearing a facemask and following social distancing guidelines, as instructed by the event’s staff and volunteers and all federal, state, and local guidelines relating to COVID-19.

SG reserves the right to change, add to, delete from, modify, or amend these Official Event Details at any time at its sole discretion.

By participating in the Event, each Contestant agrees that all decisions regarding the Event, including but not limited to the random selection of all Contestants, proxies, judging, Event guidelines, program production, Event play, penalties and disqualification determinations, technical difficulties, mechanical failures, or human errors; including but not limited to the premature reveal of any Event material or elements, the malfunction of any piece of Event equipment or electronics, the failure of any audio equipment, and the awarding of Prizes, are at the sole and exclusive discretion of SG and are final and binding on all Contestants and not subject to appeal.
